# Affordable Liability Insurance Now Available for BC Water Suppliers!

In partnership, the Sustainable Infrastructure Society (SIS), Capri Insurance and AON Reed Stenhouse have developed an affordable liability insurance program. The program provides the broadest coverage available to British Columbia's community water suppliers.

"I am confident that this SIS-sponsored Liability Insurance program is the broadest in coverage available to community water suppliers in BC" says Chris Flint, Vice President for Aon Reed Stenhouse in Victoria. "Under the SIS-sponsored policy the insured will enjoy benefits that are unavailable through other liability insurance policies."

Community water suppliers may wish to compare their current policy to the SIS-sponsored policy. The list at left highlights key benefits, many of which are not available with other programs. An explanation of these and other benefits is found on the SIS web site. Small well-managed water suppliers may enjoy these benefits for as little as \$1500 in annual premiums.

#### **Reviewing Water Rates**

Many community water systems are faced with financial challenges. They must satisfy the requirements of recent legislation, meet increasing operating costs, and find money to replace aging infrastructure. Often revenues are insufficient to meet both operating costs and to provide for system renewal.

The solution may lie in a revision of the rates charged for water. Many community water systems in BC are undercharging for the water they supply. Water rates in BC are lower than in other parts of Canada, and substantially lower than in most other areas of the developed world.

#### A New Reason to Review Your Rates?

A recent report to the provincial government contains the following recommendation:

"Develop full cost pricing of small water system operations to include the value of volunteer time and donated resources and communicate the true value of water supply costs to customers."

The absence of a "Failure to Supply" exclusion is a major benefit of the SIS-sponsored policy. The policy will respond if the water supplier is legally liable for bodily injury or property damage as a result of failure to supply water: for example, if a building is destroyed by a fire because there was no water at the fire hydrant. In this case, the SIS-sponsored policy provides protection, including coverage of legal fees. Policies which have a Failure to Supply exclusion provide no such protection.

The absence of a *Health Hazards* exclusion in the SIS-sponsored policy is also a major benefit. For example, if a water supplier experiences a Cryptosporidium outbreak which causes bodily harm, it may be open to a charge of negligence. The SIS-sponsored policy provides protection. Policies which have a *Health Hazards* exclusion provide no such protection.

The application process for the SIS sponsored program is straightforward, and response is rapid. Managers of community water suppliers are asked to go to http://www.SustainIS.org to become a

Registered User with the SIS, and then apply for the insurance online. It takes about 15 minutes to complete the application. Those who do not have access to the Internet are asked to phone the Sustainable Infrastructure Society to request an application form.

Access to affordable liability insurance is a top priority for community water suppliers in British Columbia. Many of these organizations have experienced significant increases in premiums or are unable to access insurance coverage in the first place. Community water suppliers include water users' communities, improvement districts, regulated utilities and other unregulated private systems of all sizes. Liability insurance provides protection against the risk of an organization being found liable when bodily injury or property damage occurs to a third party resulting from negligence on the part of the organization. Negligence is defined as a failure to do or not to do what a prudent person or organization would do in a similar circumstance. Increasing rates may not be an easy thing to do. We all resist increases in our costs of living. However, supplying safe, reliable and sustainable drinking water involves a wide range of costs.
